Shell Lubricants 2017 Harvest Promotion Terms and Conditions

1. Information on the offer and how to claim the offer form part of these Terms and Conditions. Participation in this Promotion is deemed acceptance of these Terms and Conditions.

2. The Promoter is Viva Energy Australia of Level 16, 720 Bourke Street, Docklands VIC 3006 ABN 46 004 610 459 and its agents in the promotion, including their officers, employees and agents (collectively called the "Promoter"). No correspondence received concerning this promotion will be entered into.

3. The promotion commences on Monday 21 August 2017 and closes at 5pm AEST on Friday 1 December 2017 ("Promotional Period").

4. 13. Entrants should allow four (4) to six (6) weeks (from the end of the Redemption Period) for delivery of the Bonus Gift.

16.
