

Gas Terminal Project Supplementary Statement Consultation Activities Plan 2023

The Minister's Directions for the Viva Energy Gas Terminal Project (the Project) environment effects statement (EES) dated 6 March 2023 provided that a supplementary statement be prepared for the Project by Viva Energy Gas Australia Pty Ltd (Viva Energy), in accordance with sections 5 and 8C(2) of the Environment Effects Act 1978. The supplementary statement is required to complete the assessment of the Project's environmental effects and inform decision making.

The current Consultation Plan for the Project was developed in response to the requirements of the *Environment Effects Act 1978* and *Pipelines Act 2005*. The Consultation Plan was accepted and published on the Department of Transport and Planning (formerly Department of Environment, Land, Water and Planning) website in April 2021. In July 2021 the Consultation Plan was updated to include an updated project timeline and project approvals schematic, and to provide for a separate rolling Consultation Activities Plan. This Consultation Activities Plan for the supplementary statement outlines Viva Energy's plan for engagement and consultation to support the assessment of the environmental effects of the Project on the marine environment, noise, air quality and Aboriginal cultural heritage with respect to the consolidated recommendations and further work highlighted in Table 1 of the Minister's Directions.

The overall objectives, principles and framework of the current Consultation Plan remain unchanged however Viva Energy has reflected on, and learnt from, the experience of the consultation process undertaken to date. The approach, as described in this Consultation Activities Plan, has been updated taking on board feedback from stakeholders and the Inquiry and Advisory Committee. Activities are focused on facilitating meaningful stakeholder involvement in the extended assessment process and providing opportunities for genuine engagement on the further work required by the Minister's Directions.
