Clyde Terminal Community Update





Clyde Terminal Conversion Project

We had previously informed the community that Viva Energy received development consent in 2015 to carry out works for the conversion of the former Clyde Refinery into a finished product bulk import and storage terminal (Clyde Terminal Conversion Project). Since then, Viva Energy has undertaken decommissioning, demolition and removal of the majority of redundant refinery infrastructure as well as construction and modification of assets so that ongoing operations can be consolidated into a smaller area.

Commencement of remaining demolition works in the Western Area

We are now planning to commence the remaining demolition works in December 2019.

These works will be confined to within the boundary of the Terminal (mainly within the South Western section) and are planned to occur over a six month period.

Work hours

Works are approved to occur between 7am and 6 pm weekdays and 8am to 5pm on Saturdays.



Works will not occur on Sundays nor Public Holidays. If these times are varied, with relevant regulatory approvals, local businesses and residents will be informed.

During these works, there may be a slight increase in noise and local vehicular movements. A traffic management plan has been developed to minimise and manage potential impacts to local traffic.

Remediation of the Western Area

We had previously informed the community that following completion of the remaining demolition activities, Viva Energy intends to commence environmental remediation of the Western Area to ensure the site meets the current standards for Commercial/ Industrial land use.

We are in the process of seeking approval from the Department of Planning, Infrastructure and Environment (DPI&E) for these works.

Following the feedback we received during consultation in 2019, we have revised some management measures that will further minimise potential impacts to the surrounding community and environment.

DPI&E will now complete their assessment of the application and make their recommendation. We will keep the community informed of our progress.



Additional Environmental Investigations in the Western Area

We are currently completing a detailed Remedial Action Plan (RAP) that will describe the remediation approach to be undertaken in the Western Area.

Additional environmental investigations have been undertaken over the last few months to assist in the development of the RAP.

The RAP is expected to be completed in early 2020, at which time Viva Energy intend to appoint a remediation contractor to undertake these works.

Subject to receiving approval from the DPI&E, we expect the remediation works to commence shortly after the demolition activities in the Western Area have been completed.
