Monitoring points 4 and 5 are not fixed points and so are not shown on the Figure. The water quality monitoring requirements are specified in the EPL 661, including licence limits for water quality parameters and volume. Monitoring data is provided for Point 1, Point 2, Point 4 and Point 5. A log of corrections to data is also provided.
