# **Description**



Viva Energy Opt-in Carbon Neutral VivaSol 1495 is a Climate Active certified product that has undergone rigorous carbon footprint analysis to achieve carbon neutral certification against the Australian Government's Climate Active Carbon Neutral Standard. The purchase of carbon offsets has been used to cancel out greenhouse gas emissions associated with the extraction, transportation, manufacture and supply and of Opt-in Carbon Neutral VivaSol 1495, by investing in projects that reduce or remove emissions. There are no physical changes to the product so there are no changeover or operability concerns and the product can be used in accordance to applications and specifications as detailed below.

VivaSol 1495 is a wide boiling hydrocarbon solvent for use in paint and thinner solvent systems where a solvent with slow evaporation characteristics is required.

Alternatively known as VIVASOL 1495 CO2 NEUTRAL.
