There are no physical changes to the product so there are no changeover or operability concerns and the product can be used in accordance to applications and specifications as detailed below.

VivaSol 2046 is a purpose made, narrow boiling range, high flash point solvent widely used in the mining industry and for a range of cleaning applications.
