Description



Viva Energy Opt-in Carbon Neutral VivaSol X3B is a Climate Active certified product that has undergone rigorous carbon footprint analysis to achieve carbon neutral certification against the Australian Government's Climate Active Carbon Neutral Standard. The purchase of carbon offsets has been used to cancel out greenhouse gas emissions associated with the extraction, transportation, manufacture and supply and of Opt-in Carbon Neutral VivaSol X3B, by investing in projects that reduce or remove emissions. There are no physical changes to the product so there are no changeover or operability concerns and the product can be used in accordance to applications and specifications as detailed below.

VivaSol X3B is a narrow boiling range, medium evaporating solvent widely used in the paint industry.
